### **Welcome to our world**

I would like to take the opportunity to respond to the article titled "Commissioner: Bring inmate to court," that ran in the Saturday, March 13, 2004 edition of the Antelope Valley Press.

In the article, Superior Court Commissioner, Victor Reichman made a decision not to hear three small claims case involving three Correctional Officers suing a convicted murderer for injuries they received in separate attacks by this inmate. The commissioner's decision not to hear the case, until the inmate was brought to court, is another issue that I will address in a future commentary. The core issue that causes Correctional Employees the greatest concern is the commissioner's comments regarding the case. Commissioner Reichman made inappropriate and opinionated comments regarding the cases. The statement that causes the greatest concern to us is Reichman statement that he "didn't want the court turning into a playpen," with frivolous lawsuits between "GUARDS" and inmates. This statement came at the end of statements to the effect that he believed that the small claims actions were a waste of taxpayer's money and that we were only going to give the inmate a free trip, with no real chance of collecting any money from the inmate. In essence, the commissioner has trivialized a case where three Correctional Officers were attacked and injured by a convicted murderer inferring the cases were frivolous. The commissioner was very inappropriate by expounding his personal opinions regarding the case even prior to hearing the arguments and merits of the case.

As a Correctional Lieutenant, working in the California Department of Corrections, who has been assaulted, and has witnessed numerous staff injured by violent inmates, I find the commissioner's statement "as a stab to the heart" of every employee working in the California Department of Corrections. It's not only hurtful, but also very disrespectful to our profession. I believe that the commissioner should be ashamed by his statements. The facts are indisputable, 9.8 Correctional Employees are assaulted each and every day in the California Department of Corrections. This assault rate has risen over the last few years with no reduction in sight. However, a Superior Court Commissioner has the gall to compare these lawsuits to frivolous lawsuits filed by convicted felons incarcerated in the California Department of Corrections. The commissioner is saying that an inmate that files a law suit due to the fact that his piece of cake was smaller than another inmate and the fact that Correctional Officer Herrera has brought suit against a convicted murderer that viciously attacked him and caused him to suffer from blackouts and seizures are the same. This is absolutely appalling and makes us seriously question his fitness for the bench. I invite commissioner Reichman into our world. Come inside the walls and have a convicted felon throw his feces and urine into your face and call that frivolous. Have a convicted felon put a "shank" into your neck and call that frivolous. Have a convicted felon slam your head into a cement floor repeatedly in an attempt to kill you and call that frivolous. This is what the men and women walking the toughest beat in the State deal with on a daily basis. Welcome to our world.
